#### **Invitation to Public Forums**

The Board of Aldermen of the City of Oakland will hold a Public Forum on Monday, October 13, 2008 at 7:30 p.m. at the Webster Groves Christian Church, 1320 Lockwood Blvd, Oakland, MO 63122 to

allow citizen input in the review of final plan master recommendations for park areas and green as well spaces, sketch concepts and cost opinions designed to help the City plan for how grant and budget funds will be used in the future to improve park areas and green spaces. This work has been done as part of a planning grant from the St. Louis County Park Grant Commission.

The Cities of Oakland and Kirkwood will hold a joint Public Forum on Tuesday, October 21 at 6:00 p.m. at the Kirkwood Community Center to review plans for the reconstruction of Holmes Avenue. The proposed improvements Holmes Avenue to consist of reconstruction of the roadway and sidewalks along with installation of concrete curb and storm sewers as necessary. Design plans will be available for citizen review and the project engineer will be available to answer questions and receive citizen input. This work is being done with the assistance of a federal grant alongside funds from both the Cities of Oakland and Kirkwood.

#### Flood Damage?

St. Louis County is developing a list of all homes and businesses that sustained damage in the heavy rains Ike following the weekend of September 14. If you had damage to the actual structure and/or contents of your home (not your yard) please send your name, address, phone number, and brief description of the damage sustained to oaklandcityhall@sbcglo or leave a bal.net message at 416-0026. Some state and/or federal Emergency Assistance funds may ultimately be available.

#### Sewer Lateral Repair Program

The City of Oakland offers residents a Sewer Lateral Repair Program. If you think you have a collapsed pipe, contact a plumber and have the line cabled at your expense. Once you have received the tape. contact City Building Inspector Greg Hanser. He will review the tape verify your eligibility. If eligible, the resident decides on a contractor to do the repair and then pays for the repair in full. Copies of the actual bill and receipt of payment can be sent to P. O. Box 220511, St. Louis, MO 63122 and reimbursement (up to \$2500) will be sent to you after the voucher is approved at the next monthly Board Aldermen meeting.
