Dear Residents:

Helmut Starr, our longtime City Attorney turned City administrator the last two years has decided to retire effective August 31. Helmut was appointed City Attorney by the late former mayor Bob Schutt in May 1989. Helmut served under seven different mayors and was appointed as City Administrator in July 2022 after he retired from the practice of law. Helmut is appreciated for countless positive contributions to our city over his nearly 40 years of service to Oakland and its citizens. Helmut was known as an expert in the practice of municipal law and Oakland was fortunate to have him for so many years representing our city.

### To replace Helmut, the Board has approved the appointment of former Mayor Andrew Stewart as our new City Administrator/City Clerk. Many of you know Andrew who lived in Oakland for 26 years before relocating to the city just north of us in May of 2023. Andrew was appointed interim city administrator for Glendale last fall where he helped guide them through several issues including spearheading their search for a new full-time city administrator. ### Snow Removal


Oakland will contract with Bluegrass Lawn & Snow Management again this winter. They took over the contract last winter. If snow is predicted, please try and park cars in driveways wherever possible to keep the streets clear for plowing.

### Sewer Lateral Repair Program

The City of Oakland offers residents a Sewer Lateral Repair Program. If you think you have a collapsed pipe (not just tree roots), contact a plumber and have the line cabled at your expense. Once you have received the video, contact City Inspector Brandon Trusty. He will review the video to verify your eligibility. If eligible, the resident decides on a contractor to do the repair and then pays for the repair in full. Copies of the actual bill and receipt of payment can be sent to P. O. Box 220511, St. Louis, MO 63122 and reimbursement (up to \$2500) will be sent to you after the voucher is approved at the next monthly Board of Aldermen meeting.

### **Building Permits**

A reminder that a permit is required for most building projects. Initial plan review is completed by Oakland and then inspections are completed by St. Louis County. If you happen to live in a floodplain or floodway, additional permits may be required. Please contact cityhall@oaklandmo.org with questions.
