#### **Mosquito Season**

The County will be monitoring mosquitoes each week this summer. If you would like to know if your area will be sprayed on a particular day, you can call the hotline at 615-4BUG around 5p.m. Spraying is just one of many tools the County utilizes to control the types of mosquitoes which are active at night and most likely to carry disease. The best way to eliminate daytime mosquitoes, which are container breeders, is to eliminate sources of standing water around your home. To report mosquito problems or to be placed on the no spray list call 727-3097.

Community Development Block Grant Hearing

The City of Oakland will hold a public hearing to discuss the allocation of \$20,000 in Community

Development Block Grant Funds which will become available after January 1, 2014. The Public Hearing will be held at 7:00 p.m. on June 10, 2013 at the Webster Groves Christian Church, 1320 Lockwood Blvd., Oakland MO 63122. #### Sewer Lateral Repair Program

The City of Oakland offers residents a Sewer Lateral Repair Program. If you think you have a collapsed pipe, contact a plumber and have the line cabled at your expense. Once you have received the tape, contact City Building Inspector Greg Hanser. He will review the tape to verify your eligibility. If eligible, the resident decides on a contractor to do the repair and then pays for the repair in full. Copies of the actual bill and receipt of payment can be sent to P. O. Box 220511, St. Louis, MO 63122 and reimbursement (up to \$2500) will be sent to you after approved at the next Board meeting.

#### Pool and Tennis Passes

Remember that the Kirkwood Pool and Tennis Courts are available to Oakland Residents all summer! In order to take advantage simply go to the Community Center to obtain an ID Card. The same card is used for the pool and the tennis courts. You then use that ID card when purchasing pool or tennis passes, camps, lessons, etc. These are amazing resources for Oakland families to enjoy throughout the summer, and we celebrate our partnership with the City of Kirkwood!

## **Remember City Codes for a Great Summer!**

Summer is an active time and an important time to remember City Codes and why they exist. For instance, in order to keep pedestrians safe, it is important for property owners to keep their trees, shrubs, and ground covers from growing over and onto public sidewalks. We should all trim hedges and ground cover next to the sidewalk, make sure tree branches clear the sidewalk by at least eight feet, and plant annuals so they don't spread over the public sidewalk. Summer is also a great time to be outdoors with pets. Please remember to use pet waste bags when in the parks, and also to respect neighbors by not leaving barking dogs outdoors that can create a nuisance. Finally, its a good time of year to remember that many building projects in the City require a permit and inspections. Admission Policies: The Aquatic Center is only available to residents of Glendale, Kirkwood and Oakland. For entry into the pool, you will need to present a Kirkwood Parks and Recreation issued ID card. No other form of ID will be accepted to gain admittance into the facility. ID cards are \$5 each, both for originals and replacements, and are good for up to three years. In order to obtain an ID card, each purchaser, 16 and over, must present a valid and current Missouri Driver's License (or State of Missouri ID card), showing resident address and a current utility bill (gas, water, electric, or phone), bank statement, or voter ID card, issued to their home address within the last three months. Purchasers age 15 and under must be accompanied by a person at the same address who can present the documents listed above. Each ID card holder will be allowed up to 4 guests per day, with a maximum allowance of 16 guests per family each day. All guests will pay non-resident daily admission fees.
